Greens, Fine Turf, Sports Turf, Fairways, Lawns and Landscapes.	250-500ml	25 – 50L	Apply BIOWETT™ PREMIUM in at least 400L water per hectare. Apply prior to rainfall/irrigation to maximise moisture utilisation. Irrigate immediately following application when temperatures are expected to exceed 30°C within 24 hours of application.

GENERAL INSTRUCTIONS
BIOWETT™ PREMIUM is a highly innovative and proven solution developed by SACOA to combat the significant problems of hydrophobic soils. This unique product aids in reducing the frequency of irrigation to combat the issues of water restrictions and lack of water resources. When applied following these label instructions, **BIOWETT™ PREMIUM** will overcome water repellency and improve water utilisation in all forms of turf management. **BIOWETT™ PREMIUM** gives best results when applied regularly, prior to rainfall or irrigation. Avoid application when turf is suffering heat and/or moisture stress.

MIXING & COMPATIBILITY
BIOWETT™ PREMIUM mixes readily with water, liquid fertilisers, trace elements and crop protection products. Add the required amount of **BIOWETT™ PREMIUM** to the desired amount of water in the spray tank. Gentle mixing will minimise foam generation. Jar test for compatibility prior to mixing large volumes.

APPLICATION
 Apply **BIOWETT™ PREMIUM** in early Spring, early Summer and again in early Autumn to protect against Localised Dry Spot (LDS) and water repellency. For best results, water the area to be treated prior to and after application. Water in well immediately after application otherwise there could be a risk of turf discolouration if product remains on the leaf surface.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT
 DO NOT contaminate streams, rivers, or waterways with the chemicals or used containers. A strategy to minimise spray drift should always be employed when applying spray within 50m of aquatic environments.

STORAGE AND DISPOSAL
 Store away from oxidising agents. Keep container securely closed when not in use. Store in the closed original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. In accordance with local law.
